
## **SRHR & Climate Change**

## It's a celebration for Maputo



We participated in the 3rd Annual Girls Festival in Nairobi, Kenya, celebrating the 20th Anniversary of the Maputo Protocol. The event highlighted the comprehensive rights guaranteed to young women, including improved autonomy over their reproductive rights, through international human rights instruments established by the African Union (AU). We acknowledged Kenya's progress since the protocol's adoption and ratified it in the country. Advocacy for full protocol implementation and budget allocations was a central focus, with a call to remove the reservation on Article 14(2)(c) to ensure reproductive rights protection for women in cases of sexual assault, rape, incest, and health endangerment.

CSA actively engaged in Kenya's Universal Periodic Review (UPR) process through the We Lead program and Repositioning CSE in Kenya project (RFSU). As part of a collaborative effort led by the East African Centre for Human Rights, we contributed to developing a Simplified Advocacy tool for the UPR process. This tool empowers CSOs to assess the 3rd cycle recommendations, the Kenyan government's commitments, achievements, and outstanding actions. With our support, we are committed to ensuring that Kenya fulfills 100% of its commitments, especially in the SRHR thematic area.


## **Religious leaders for CSE!**



CSA convened religious leaders from different faiths for a two-day workshop on Comprehensive Sexuality Education, advocacy, message, and delivery. Present in the workshop were representatives from the youth task force and a few CSOs working in the SRHR field. The workshop agenda reflected the need for SRHR and reviewed CSE's national status. Also, part of the discussions were some challenges regarding CSE (in and out of school), with religious leaders opting to refer to it as Human Sexuality Education. As a way forward from the workshop, was the need to identify potential advocacy forums to amplify CSE/ Human Sexuality Education and identify synergy areas.
